One particular industry that has seen increased investment in digital infrastructure and digital skills is healthcare. Globally, many healthcare systems struggled in the earliest stages of the COVID-19 pandemic. Also, in the post-COVID-19 era, healthcare organizations and systems are addressing key challenges of providing high-quality, efficient, and accessible care while facilitating the (tele)monitoring and management of exponentially increasing chronic diseases such as obesity, chronic obstructive pulmonary disease, diabetes using digital technologies.

While the disruptive innovations reshaped individual work behavior, organizational structures, and collaborations, many theoretical perspectives fall short of understanding the new reality. Moreover, rapid expansion and adoption of digital innovation provide many opportunities to discuss and rethink the theoretical and methodological underpinnings to understand how these innovations are used in practice.

To this end, we would like to invite scholars, practitioners, and research students to submit original works taking any theoretical, practical, and methodological perspective and present their papers and findings to the 23rd IFIP Conference on e-Business, e-Services, and e-Society to be held from 11 until 13, September 2024 at the Open Universiteit, Heerlen, the Netherlands. Theoretical and empirical papers employing quantitative, qualitative, and/or critical methods are welcomed.

Submission Guidelines

Authors should submit original, unpublished research papers. All papers must not simultaneously be submitted to another journal or conference. All accepted papers will be published in the conference proceedings. Therefore, submissions should not be under consideration for any other conference or journal outlet.

Authors should consult **Springer's authors' guidelines** and use their proceedings templates to prepare their papers.

Length of Papers

The most common types of papers accepted for publication are full papers (12 pages max) and short papers (6-7 pages). We only wish to publish papers of significant scientific content.

Special Issues

Authors of selected papers will be invited to submit an extended and revised version of their paper for fast-track review and publication in the following journals.
